

### **SUBPART 2: PASSENGER SAFETY CHARGE**

#### **Fees for passenger safety charge**

**187.02.1** A fee of R 29.33 shall be paid by an aircraft operator in respect of an aircraft passenger departing on an aircraft from an aerodrome within the Republic on a scheduled public air transport flight or as part of a flight to a destination within or outside the territory of the Republic.”.

#### **Short title and commencement**

3. This regulation is called the Twenty-Seventh Amendment of the Civil Aviation Regulations, 2023 and shall come into operation 30 days after publication in the Government Gazette.
